Our chapter and Region X continue to champion for all Florida appraisers through legislative efforts. The 2023 regular legislative session is active and goes to May 5. Of note for appraisers this season is HB 213 / SB 938, <u>Limitation of Actions Involving Real Estate Appraisers and Appraisal Management Companies</u>, and changes to the Statute of Repose. This will protect appraisers from frivolous lawsuits and close a loophole which allows appraisers to be sued years after they have submitted an appraisal report.

The AI 2023 Joint Region meeting was held this year in San Antonio, Texas on February 20-21. Ken Terrell, MAI, and I were the chapter regional representatives who attended and it was great putting faces with names. All AI Regions participated in the events with many being standing room only. Topics of discussion included the rollout of a new website, changes to the candidate program timeline, AI PAREA, and a DE&I action plan. Emphasis was placed on refreshing the AI brand, social media presence, and the website. There are many great things to come with actionable items in the works.

You will also be joined by our Candidate Guidance Chair, Laura Carroll, MAI, (a recent designee) our president, Will Faber, MAI and Past President, Randy Rex, MAI, who will all be there to answer any questions or offer some helpful advice.

As you should already be aware, the criteria to be considered a Candidate for Designation has changed, but the path is still the same. If you are currently a Candidate for Designation and do not plan to complete your designation by the end of 2023, you can transition to the Practicing Affiliate category until you complete the outstanding education requirements and retransition into the Candidate for Designation program. If you are not already a Candidate for Designation, you will need to wait until you have completed your advanced education to apply for candidacy.

Government Relations Update

As of the date of this writing, Tallahassee interests of foreign countries;" This is working on two separate pieces of legislation, that, if put into law will have a direct effect on Appraisers. A short summary of each bill is included below. Interests of foreign countries;" This legislation would bar certain foreign countries; This is a multiuse piece real estate. This is a multiuse piece summary of each bill is included below.

The first, Senate Bill 398 and House Bill 213, deal with the statute of limitations on Real Estate Appraisers and Appraisal Management Companies for having a lawsuit filed on your work. The current House bill specifies 7 years after the appraisal, the current Senate bill within 2 years of discovery (of alleged act or omission) or 4 years after the appraisal. Both bills exclude complaints of fraud and any State Board investigations.

The second is Senate Bill 264 and House Bill 1355. "An act relating to

interests of foreign countries;" This legislation would bar certain foreign countries from purchasing certain Florida real estate. This is a multiuse piece of legislation, as it also deals with health care information and personal information that would be a part of any future government contract. Real estate is specified as agricultural lands and lands located near seaports and military installations. The current list of countries/entities/citizens on the no purchase list include China, Russia, Iran, North Korea, Cuba, Venezuela and Syria.

The Florida legislative session is scheduled to run through May 5. You can check the current status of these bills on www.FlSenate.gov
